TRUST ISSUES SCENARIO FOR OPEN DISCUSSION

1. ALEX & VICKY

Vicky sat at the kitchen table, stunned and hurt. Her 4 year old marriage to Alex, on which she had pinned so many hopes and dreams, seemed false. She had just heard from a friend that Alex had been seen lunching with an old girlfriend.

When Vicky asked why he hadn't mentioned it to her, his reply was defensive: "I knew you would freak out, like you're doing now." Alex could not see how that omission had undermined Vicky's trust in him, his character and their relationship.

What are the trust issues here? (on both parts).

2. LUKE & JADE

Luke told Jade about a business opportunity abroad with a couple of his friends. After going over the paper work, she agreed that they would invest in the business.

It was whilst checking that she saw another document with Luke & Betty's names on. This caught her attention because Betty was Luke's ex from secondary school days.

To cut the long story short, the so called friends Luke was investing with happened to be Betty. He said he knew Jade might not agree to the deal if he had told her it was Betty, however the deal was quite viable and he was doing it for the family anyway.

3. TONY & SANDRA

He has just discovered that she has been diverting funds from their joint account to a personal account to pay for the school fees of her sister's children without his knowledge.

All the while he was made to believe she was putting money aside as educational fund for their own children. She knew that it has been a difficult 2 years for the family and particularly himself as he had to forgo a lot of things to make ends meet. How could she deceitfully prioritise another family above theirs?

6. <u>JOHN & MARY</u>

John and Mary operate a convenient 50-50 financial responsibilies where each has allocated financial responsibility for the various bills. Mary pays the Council Tax, Child minder and internet subscription bills. On one of John's day off, he had balliffs come to the house, and discovered that Mary had not been paying Council Tax, and a few utility bills, and she has been to Dubai twice that year for her friends 40th birthday.

The childminder also complained to John when he went to pick up the twins that Mary regularly comes late to pick up the kids, and has not settled the resulting late charges applied to the fees for months. This is the first John is aware of the financial lapses and is feeling quite insecure as he, being financially astute, has never been late on a payment in his life
